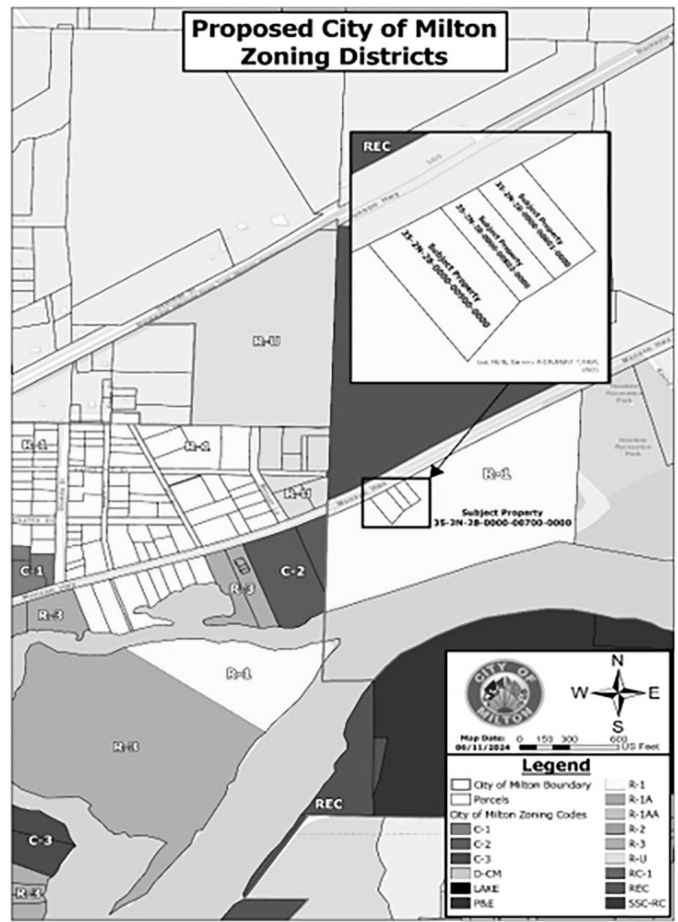
**PUBLIC NOTICE**
